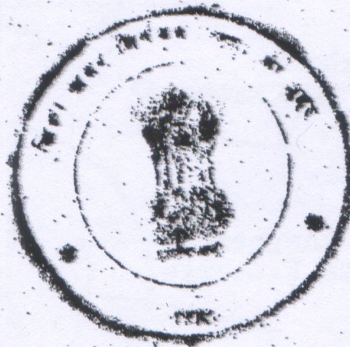

16. AIMS OF THE TRUST :

The aims, objects and purposes for which the trust is established are inter alia the following:-

- (a) To help the poor students by providing books and copies for their study in schools .
- (b) To help women who are not caste in the society due to their social weakness.
- (c) To extend adult education to the poor who are illiterate

- (d) To establish charitable dispensaries for poor patients of the Society.
- (e) To establish sewing training centres for the upliftment of the women especially for poor.
- (f) To establish educational institutions for the benefit of the students specially for the poor.
- (g) To make awareness among the poor parents to send their wards to the schools.
- (h) To render help to the orphans, destitutes, physically and mentally handicapped and socially backward people.
- (i) To award scholarships to the poor and meritorious students.
- (j) To educate illiterate and poor and to make all necessary arrangement for the same.
- (k) To engage teachers, professors, instructors and experts of good moral character and conduct to impart efficiently and economically upto date institution to pupils and students.
- (l) To develop a healthy as well as critical attitude towards the development of mental, physical and moral uplift of the students and all those connected with the institutions so as to make them good citizens.

12. Area of Operation:-

13. Function of the Board of Trustees.

Subject to the provision of the rules, the functions and powers of the Board of Trustee shall be as follows :-

- (a) To carry out, promote and advance the aims, objects and purposes of the trust as the rules laid down herein.
- (b) To control, direct, co-ordinate, guide and supervise all the welfare centres, institutions, running under the trust.
- (c) To administer and control the affairs and funds of the trust and exercise all powers of the trust.
- (d) To do all other lawful acts, matters, things and deeds, as may be conducive to or expedient in the interest of the trust.
- (e) To give approval to the actions taken by the Managing Trustee.
- (f) To prescribe salaries, emoluments, gratuity, wages, over-time and legal and necessary charges payable to the
